<p>Are unsolicited grants accepted or do I need an invitation code?</p>	<p>Organizations may not submit a grant request without an invitation code. A pre-application Letter of Inquiry is required in order to obtain an invitation code. Click here to obtain the Letter of Inquiry (LOI) document: www.cybergrants.com/boeing/loi</p>								
<p>If I need an invitation code, how do I acquire one?</p>	<p>Once you have submitted the LOI electronically to your local GCC Community Investor, your request will be reviewed and you will be contacted with an invitation code or to further discuss your grant request.</p>

Boeing: Corporate Focus Areas/Objectives</p>	<p>Currently, we accept grant applications in all five focus areas but funding priority will be given to programs that focus on Child Care and Early Learning (Pre-K), K-12 Teacher Professional development, and workforce development initiatives.</p>								
<p>Does your local grant making concentrate on specific issues within the standard Boeing focus areas? Boeing: Corporate Focus Areas/Objectives</p>	<p>We work within the five enterprise-wide focus area objectives to develop a site-specific plan tailored to the particular needs of the China community. Overall, our charitable investment decisions are based on identifiable outcomes that provide the maximum benefit to the community and meet real needs in the short term but have broader positive effects beyond the period of our involvement. Funding priority is given to programs that focus on Child Care and Early Learning (Pre-K) and K-12 Teacher Professional development programs. Specifically, grant requests are evaluated on:</p> <ul style="list-style-type: none"> • Alignment with our corporate focus area objectives, company values and core competencies • Clearly defined expected outcomes relative to community needs, that are measurable, scalable, and have a sustainable impact on the community beyond the period of the company’s involvement • The extent to which the project or program demonstrates innovation, collaboration, leadership and diversity • The organization’s financial viability, programmatic strength, and legal compliance 								
<p>Do you accept requests for in-kind donations and if so, what do you generally donate?</p>	<p>Typically, we do not accept requests for in-kind donations.</p>								
<p>May I apply for multiple Boeing resources? (i.e., Corporate cash grants, Employee Community Fund (ECF), business sponsorships and in-kind resources?)</p>	<p>No, because resources are limited, we ask that you decide which support best fits your agency needs and apply for that type of funding.</p>								

May I request employee volunteer support whether or not I request a cash grant?	Yes, we have volunteer programs throughout the year. If you have a volunteer need for a specific event or skill that our employee's may have, please contact the local GCC Community Investor at the email below.
