



## 2025 ECF Grant making Guidelines

### Arizona ECF Chapter

**Arizona Chapter Grant making Committee (CGC)** members are active in the community and ensure every grant is worthy. All donations are from Arizona Boeing Employees and 100% of contributions are invested into the community across Arizona. The Arizona CGC reviews grant requests every year. There is no guarantee an organization will receive funds regardless of how many times we have given to that organization in the past. ### ECF focus areas

Arizona CGC funding categories include: **Health, Education, Community Enrichment, and Social Services.**

### ECF funding criteria

1. Agencies must fall within the requirements of Section 170(c) of the Internal Revenue Code and must also qualify with the Internal Revenue Service as a Section 501(c)(3) organization.
2. Agencies must be designated as a 501(c)(3) for at least three years prior to submitting a grant.
3. Agency must plan to use any provided funding to benefit only Arizona and Arizona communities.
4. Agencies may submit only one grant application per calendar year.
5. Agencies must re-apply for funding each year. The CGC makes no implication that any agency is guaranteed funding from year to year.
6. Agencies must apply using Boeing's online grant application. Hard copy submissions will not be accepted.
7. Update your agency's contact information and login information as necessary each time you apply for a grant.
8. Proposal information should be specific to the requested grant (i.e.; # of people the requested project will serve, not people the organization serves at large; financial information specific to local organization, not parent organization). If your agency is part of a national organization, please submit financial documents reflecting your local operations.
9. Grant proposals may be funded in full, in part, or declined. Keep in mind that the average funding amount of successful grant proposals may be between \$3,000 – \$15,000.
10. There is no formal schedule requirement. An organization can reach out to request an invite throughout the year.
11. Agencies will be notified once funding decisions have been made.

### ECF does not fund

1. Political organizations or programs
2. Organizational activities promoting fraternal, sectarian, social, religious, churches, service clubs, or similar agendas
3. Individual public and private schools, except those dedicated solely to the handicapped
4. Organizations supported in large part by government funding, except joint government and private enterprise projects
5. Trips, tours, award ceremonies or fundraising sponsorship (of individuals or groups)
6. Fundraising, management and general expenses, event expenses including courtesy advertising, conferences or dinner tickets
7. Scholarships or endowments
8. Youth sports groups



## How to be considered for a grant

**For brand new organizations in STAR System or if e-mail address has changed**, email [MesaECF@boeing.com](mailto:MesaECF@boeing.com) for the CGC to initiate an application for you. Once 501(c)(3) is researched by ECF an invite will be sent to access the grant process. An invite to submit a formal grant request is not a guarantee. ECF members try to determine initial eligibility for organizations prior to official approval.

**To Apply click on "STAR System"** if you applied previously or were an existing organization in Cybergrants, with a current email address used in Cybergrants, you may go to <https://boeing.smartsimple.com> and click 'forgot password' to create a new password. Once you login, you will see where you can start a new ECF application. Only apply if you received an invitation to submit a grant proposal.

## Organization eligibility

- Only organizations that are in good financial standing and have had an Internal Revenue Service designation as a nonprofit 501(c)(3) public charity (or similar designation under the relevant law for international organizations) for at least two years will be eligible to apply for a grant.
- Certain types of organizations will be ineligible to apply for grants including: (1) organizations that denigrate or advocate discrimination or violence toward any racial, ethnic or cultural group; (2) political organizations; and (3) fraternal, sectarian, social, religious, or similar organizations.
- Grant recipients will comply with all applicable laws and regulations of the United States and, where necessary, the nation of registry and/or operations, including, but not limited to, the U.S. Foreign Corrupt Practices Act, the USA Patriot Act, and the U.K. Bribery Act.
- The agency's services must be open to all regardless of age, gender, race, religion, sexual orientation, national origin, and presence of disability, ability to pay or other background. Prioritizing agency services and targeting therapeutic programs to specific populations will not disqualify an agency from consideration. Furthermore, the agency must not discriminate against its staff or volunteers based on age, gender, race, religion, sexual orientation or identity, national origin, and presence of disability, or other background.

## Documentation required with application

All applicants will be required to complete an electronic application that includes a grant proposal and a written agreement setting forth the terms of the grant. The application requires:

### Financial and Organizational Disclosures

- ☐ Mission statement
- ☐ Organization's operating budget
- ☐ Breakdown of funding sources
- ☐ IRS 990 and/or audited financial statements
- ☐ IRS determination letter
- ☐ Governing board members and their affiliations
- ☐ Top five highest paid staff members

### Project Disclosures

- ☐ Project budget
- ☐ Detailed description of the project and the community needs the project seeks to address
- ☐ Expected outcomes of the project
- ☐ Number of people who will benefit from the project



## ECF grant application access

Please follow these instructions if you have previously applied for an ECF or Boeing grant:

1. Go to Boeing's grant application website ([https://boeing.smartsimple.com/s\\_Login.jsp](https://boeing.smartsimple.com/s_Login.jsp)).
2. Enter your password or select **Forgot Password**.
3. Enter your organization email address in order to get a link sent to that email with instructions to update your password.
4. Create an updated password and then log in.
5. Complete your organization's profile. (Some information might have carried over from a previous application.)
6. Initiate and complete the ECF application online.
7. Utilize the "Need Support" link at the bottom of each screen of the online application to help answer frequently asked questions.
