EXEMPTIONS

During the hours aforementioned, exemptions are granted to aircraft declared on emergency or with an operational incident, state flights, flights on urgent humanitarian purposes, flight affected by traffic congestion at the airport and flights which cancellation may lead to problems of a severe nature at the airport of origin or destination

2. Departure operations are forbidden on RWY 25, to four-engined aircraft which do not comply with ICAO Annex 16 Chapter 3 Standards.

Specific exemptions to this restriction may be granted upon previous approval by the airport administration and for duly justified technical reasons, whenever any of the following conditions take place for the remaining runways:

- cross winds of over 25 kt on runways
- friction coefficient lower than 0.30
- runway unserviceable
- other operational conditions of an exceptional nature.
