Every operator of turbo-jet aircraft shall ensure at all times that aircraft are operated in a manner calculated to cause the least disturbance practicable in areas surrounding the airport. These requirements may at any time be departed from to the extent necessary for avoiding immediate danger.

Climb straight ahead to at least 1500ft aal before turning on to course.
